1. Buyer(s) must take the Puppy to a licensed veterinarian within 48 hours from the time of pick up or delivery.
2. The Puppy is to be spayed/neutered within 2 months of being placed or by 6 month of age.
3. The spay/neuter certificate must be mailed/mailed to the Sellers within 2 months of procedure or by 8 months.
4. The Buyer(s) gives the Sellers and/or Sellers' veterinarian consent to contact the Buyer(s)'s veterinarian to confirm the procedure.
5. The Puppy is NOT to be bred or used for studing or stud service.

6. Any implied health warranty is void if the Buyer(s) does not make a licensed veterinarian visit within that time.
7. This Puppy is to be kept as a house companion only.
8. Extensive time outside, in a garage, barn or tied up outside is NOT allowed.
9. The Puppy is to be kept in the Buyer(s)'s living quarters either free-roaming or confined in a suitable, pet-safe area at least 4 foot by 4 foot per Puppy.
10. Buyer(s) understands this Puppy is a companion Puppy and needs to live with the family.
11. The Buyer(s) agrees to update, on a yearly basis, to the Sellers via email.
12. The Buyer(s) are to forward any changes to the Buyer(s)'s contact information (address, email and phone numbers).
13. The Buyer(s) are to forward any change of veterinarian information.

FIVE YEAR HEALTH GUARANTEE

1. Diet and nutrition is one of the most important decisions the Buyer(s) can make for his/her Puppy because it has such a significant impact on the Puppy's quality of life and long-term health. The Sellers are serious about promoting long-term health for their Puppy.
2. The Puppy has been fed NuVet Plus™ daily to provide the nutrients required for optimal immune system performance and is required to stay on NuVet Plus™ for the entire first 5 YEARS of the Puppy's life*. NuVet Plus™ is an immune system builder with a precise balance of vitamins, minerals, omega fatty acids, amino acids and high-potency antioxidants known to boost immune system function. All of NuVet Labs' ingredients are sourced in the United States, manufactured in a human-grade U.S. FDA registered pharmaceutical laboratory, and cold processed to maximize the potency of the nutrients. It's not available in stores, and is only available to the general public with an order code from an authorized pet professional. The Buyer(s) can order directly from the manufacturer by calling 800-474-7044 and using order code #72037 or order online www.nuvet.com/72037. Every time the Buyer(s) receives a new shipment from the company using order code #72037, the company will notify the Sellers. The Sellers will print this information out and put it in the Buyer(s)' file. This allows the Sellers to know if the Buyer(s) is keeping their Puppy on NuVet Plus™. If the Buyer(s) does NOT want to purchase NuVet Plus™ immune system builder OR cancels at any time then this entire health guarantee will be null and void and the Puppy will be sold "as is" with NO benefits of any kind.

PUPPY CARE AGREEMENT

1. The Puppy will have a minimum of 2 set of puppy vaccine before leaving Ridgelake Chinese Cresteds. Buyer(s) agrees to give the Puppy the rest of the puppy vaccine, if not already given at Ridgelake Chinese Cresteds, at 6 weeks and 8 weeks of age or at intervals recommended by the Buyer(s) veterinarian.
2. The Buyer(s) agree to NEVER give more than 1 vaccine at a time. There should be a minimum of 2 weeks between vaccines and any other procedures, like spay or neuter, or rabies.
3. The Sellers do NOT give the Lepto vaccine. If the Buyer(s) and their veterinarian decides to give the Puppy the Lepto vaccine, any side effects will not be covered by this contract. Lepto can cause severe neurological and other physical problems, even death.
4. The Buyer(s) will have the Puppy checked by his/her/their veterinarian yearly, given proper yearly medical, preventative care and teeth cleaning.
5. The Buyer(s) will have the Puppy groomed, cleaned and properly maintained. It is understood by the Buyer(s) that this Puppy requires regular bathing, brushing, nail trims, teeth cleaning, ear cleaning, etc.
6. The Buyer(s) understands and agree not to feed food or treats, not to use house hold products and any items that are known to be unhealthy, poisonous or could cause damage, injury or death to the Puppy.
7. The Buyer(s) understands and agree that the Sellers have the right to reclaim the Puppy at any time for either or any of the following reasons:
 - a. Abandoned, left at a Veterinarian's office unclaimed, ASPCA, Humane Society, or any other legal body, City authority, etc.
 - b. A charge laid against the Buyer(s) by the ASPCA, Humane Society, or any other legal body, City authority, etc.
 - c. Poor care of Puppy's physical and/or mental health.
 - d. Improper fencing/chaining and/or brutality of the Puppy.
 - e. If any monetary changes are pending by any of the above mentioned institutes or authorities at the time that the Sellers acquires the Puppy back, the Buyer(s) is responsible to pay for these fees and related costs.

8. If at any time during the Puppy's life, should the Buyer(s) no longer want the Puppy and/or can no longer care for the Puppy:
 - a. The Buyer(s) cannot sell, put up for adoption, re-home, give away, leave at a shelter or dispose of the Puppy in any manner
 - b. The Sellers reserve the right to buy the Puppy back for the amount of \$1.00 (One U.S. Dollar)
 - c. The Buyer(s) and the Buyer(s)'s heir(s) and/or family member(s) agrees to relinquish all rights to the Puppy and sign any necessary paperwork back to the Sellers if the Puppy is coming back to the Sellers.
 - d. The Buyer(s) may rehome the Puppy with a family member or friend with the written consent of the Sellers. The Buyer(s) agree to have the Sellers interview the new family through the same adoption process by filling out a puppy adoption form and being interviewed by the Sellers to make sure the new family is knowledgeable and is able to care for the Puppy.
 - e. All related costs of bringing or sending the Puppy back to the Sellers or sending the Puppy to the new family is the responsibility of the Buyer(s).
9. Deposit is non-refundable. Any partial or full payment is non-refundable. If for any reason the Buyer(s) chooses not to adopt, changes their mind about adopting or cannot adopt a puppy due to lifestyle change or any other reason, the deposit or payments is transferable to another Puppy one time only.
10. If the Sellers choose not to place the Puppy with the Buyer(s) or cannot place the Puppy, then the Sellers will either refund the Buyer(s) the deposit and or all payment towards the Puppy or transfer the money to another puppy depending on what the Buyer(s) prefers.

The Buyer(s) understands that this Puppy should live for many years and undertakes to keep this Puppy in good care, healthy and sound.
